

During the EMA/CAMP IMI Qualifying Mediation Skills course, learners will:

- Work their way sequentially through the online course and participate in the live, online, synchronous sessions as scheduled.
- Read and watch content presented within the online course, and be directed to articles and websites on the internet to discuss in the subsequent facilitated session.
- View segments of the mediation scenario, Kumar v. Kumar, with mediator Laila Ollapally, and hear Bruce Edwards' commentary on the skills and techniques presented.
- Hear from Edwards Mediation Academy (EMA) experts uniquely qualified to share valuable lessons on the skills/techniques and necessary competencies to be an effective mediator.
- Engage in activities to reflect on their current level of understanding on a variety
 of topics and build on this baseline knowledge in both the online course
 component and in the live facilitated sessions.
- Complete an assignment at the end of each online module to measure their retention of the information provided. These assignments will be evaluated by Bruce Edwards and other EMA professional staff, providing the learner with valuable feedback. Students must receive 90% or above on at least 8 out of 9 assignments.
- Attend and participate in the live facilitated sessions, held online, with EMA/CAMP trainers and assessors. These sessions include Q&A with Bruce Edwards and/or Laila Ollapally, discussion of utilizing the lessons and skills in the Indian legal context (localizing the learning), exercises designed to utilize the skills and knowledge obtained in the online course, and coaching & practicing mediation skills in a simulated environment through role plays specifically developed for that module.
- Participate in a final role play assessment with EMA/CAMP assessor and coaches where they will be given a formal assessment of their competence as a mediator.
- The program is structured in a Tell See Do Format. Participants have the opportunity to hear lectures from experienced mediators/ watch the expert



mediator in action/ engage in a roleplay to practice their learning. Q&A sessions with the expert are held after role play so participants have the full experience of study before accessing the expert for query resolution.

Topics and the order they are presented, including lectures, exercises, shadowing of a mediation, role play, Q&A, facilitated discussion and localization **synchronous learning session is indicated in green**, **asynchronous learning sessions is indicated in blue**) A typical schedule is outlined below:
