

Privacy Policy for Course Assessments and Participants

Effective Date: 30th September, 2020

1. Introduction

We are committed to protecting the privacy and security of the personal information of participants in our course assessments. This Privacy Policy outlines the types of personal data we collect, how we use it, how we protect it, and the rights of participants regarding their data.

By participating in our course assessments, you agree to the collection, use, and processing of your personal data as described in this policy.

2. Information We Collect
